	<p>cyfnod mwy blaengar na ni. Green Gen wedi cael trwydded i ddosbarthu trydan – mae cyfle i ymateb i hyn. Mae Cefin Campell, Jonathan Edwards ac Adam Price i gyd yn gweithio tu ôl i'r llenni. Bydd y Cyng Roger Daniel yn ymateb i'r ymgynghoriad diweddaraf ar hawliau dosbarthu ar ran y Cyngor Cymuned. Cynhelir cyfarfod nesaf y Grŵp Gweithredu ddydd Llun nesaf. <i>An action group had been set up and Cllr Roger Daniel and Cllr Dave Bartholomew both sit on this. The group are both against the Pylons and Wind Turbines. Cllr Penny Izienicki has created a document called 'Wales is not for Sale'. Cllr Roger Daniel to circulate. Llandovery are also against the Pylons but are at a more advance stage than us. Green Gen have been granted a licence to distribute electricity – there is an opportunity to respond to this. Cefin Campell, Jonathan Edwards and Adam Price are all working behind the scenes. Cllr Roger Daniel will respond to the latest consultation on distribution rights on behalf of the Community Council. The next Action Group meeting is next Monday.</i></p>

Mae aelodau o’r cyngor cymuned yn aelodau o’r grwp protest felly rwy’n siwr byddant yn medru	

rhannu'r gwybodaeth diweddera ar hyn. Mae Ben ac Elin yn gwneud ei gorau glas i gael y cables dan ddaear. Hefyd rydym yn ffodus bod Cefin Campbell Aelod Senedd, o'r un farn ac yn lleisio hyn yn gyhoeddus.

O ran y ffiniau, rwy wedi cael sgwrs gan Roger am hyn. Mae'r proposals yn creu tipyn o ofid i cyngor cymunedau eraill hefyd. Noder ei fod yn bwysig i unigolion o fewn y gymuned i ymateb i'r ymgynghoriad yma yn ogystal a'r cyngor cymuned. Heb nifer o ymatebion fydd Llyw Cymru yn cymryd ateb y cyngor cymuned fel unigol – dyna'r rheswm rwy wedi dewis ei hysbysu ar tudalen fb y ward, er mwyn codi ymwybyddiaeth leol ac i roi cyfle i bobl drafod a chael cyfle i ymateb. Hefyd byddai werthson am ba effaith fydd y gwahnaol 'precept' ym mhob Cyngor Cymuned yn cael os fydd rhaid uno.

Falle byddet yn medru atgoffa pawb fod etholiad y Comisiynydd Heddlu yn cael ei gynnal ar 2ail o Fai ac mi fydd angen 'photo ID' ar gyfer pleidleisio.

Regarding the Agenda, I understand that Mr Ben Lake has sent a letter to the protest group regarding a campaign against the pylons giving an update. Members of the community council are members of the protest group so I am sure they will be able to share the latest information on this. Ben and Elin are doing their best to get the cables underground. We are also fortunate that Cefin Campbell Member of the Senedd, is of the same opinion and voices this publicly.

As for the boundaries, I have had a conversation with Roger about this. The proposals create a bit of worry for the council of other communities as well. Note that it is important for individuals within the community to respond to this consultation as well as the community council. Without a number of responses, Welsh Gov will take the community council's answer as an individual - that is the reason I have chosen to notify it on the ward's fb page, in order to raise local awareness and to give people a chance to discuss and have a chance to respond. It would also be worth talking about what effect the different 'precept' in each Community Council will have if they have to merge.

Perhaps you could remind everyone that the Police Commissioner election is being held on the 2nd of May and a 'photo ID' will be required for voting.
