Peilonnau a Twrbeinni Gwynt / Pylons and Wind Turbines Roedd nifer o drafodaethau yn dal i ddigwydd, gyda'r angen i'r Cyngor Cymuned cael adroddiadau anibynnol wedi eu gwneud e.e. ecoleg, effaith ar dirlun hanesyddol, adeiladau rhestredig ayyb. Penderfynwyd holi i'r cwmnïau megis Bute a GreenGen beth yw eu hymateb i'r ymgynghoriad diweddaraf ac wedyn gofyn iddynt ddod i gyfarfod y Cyngor Cymuned er mwyn trafod ymhellach ac efallai cynnal cyfarfod agored. Pasiwyd i roi cofnodion cyfarfodydd gyda chynghorau ar hyd y Teifi a llwybr y peilonnau ar y wefan. <i>A number of discussions were ongoing, with the need for the Community Council to have independent reports made e.g. ecology, impact on historic landscape, listed buildings etc. It was decided to ask the companies, Bute and GreenGen what their response is to the latest consultation and then ask them to come to the Community Council meeting in order to discuss further and possibly hold a public meeting.
