cyfarfod gyda ni ar lafar. Penderfynwyd y byddai'r Cyng Bartholomew a'r Cyng Aldridge yn edrych i weld pwy yw'r 14 CC arall, ac mi ddaeth cynnig gerbron bod cyfarfod agored yn cael ei wneud yn y pentref i ofyn am farn y gymuned. Cyng Bartholomew a Cyng Aldridge i drefnu hwn.

Waunmaenllwyd – Mae angen trafod y gronfa ariannol a penderfynu os yw'r CC yn mynd i'w arwyddo. Y Clerc i ddanfôn ogwmpas y dogfennau drafft sydd wedi eu derbyn. Mae'r cais cyn-cynllunio wedi ei lawnsio hefyd, ac mae angen i'r CC ymateb. Wedi'r cyfarfod fe wnaeth y Cadeirydd alw cyfarfod brys i drafod materion Waunmaenllwyd yn unig ar y 23ain o Hydref yn Neuadd Cellan.

An email was received from Gabriel Izienicki on behalf of Caru Teifi asking questions to the Community Council about their part in applications for the green energy projects. These were discussed, members of the public were allowed to speak, and the Chairman said that a written response would be made. Broadly these are the questions and answers:

- 1) Is there a Biodiversity scheme with the CC - Yes*
- 2) Is the CC going to deliver their own EIA Assessments to PEDW - No*
- 3) Has the CC been in meetings with developers - Yes*
- 4) Has the CC met with, or means to meet with people who are in favour of the plans - No*

Feedback was received from Cllr Dave Bartholomew, Cllr Rhys Williams and Cllr Eryl Evans from the meeting with Bute Energy on Lan Fawr - the Community Council has not received any correspondence from them - the Clerk to ask if information should be provided. We understand that there are 14 other Community Councils to be part of any community financial fund. Bute has offered to meet with us. It was decided that Cllr Bartholomew and Cllr Aldridge would look to see who the other 14 CCs are, and a proposal was made that an open meeting be held in the village to ask for the community's opinion. Cllr Bartholomew and Cllr Aldridge to organise this.

Waunmaenllwyd – The community fund needs to be discussed and decide if the CC is going to sign it. The Clerk to email the draft documents that have been received around again. The pre-planning application has also been launched, and the CC needs to respond. After the meeting the Chairman called an extraordinary meeting to discuss Waunmaenllwyd issues only on the 23rd of October in Cellan Hall.

	<p>Y Cyngor wedi prynu fferm Llety Twpa ar gyfer addysg. Yr arian wedi dod wrth Llywodraeth Cymru. <i>The Council have bought Llety Twpa farm for educational purposes. The money has come from Welsh Government.</i></p> <p>Biniau / Bins – Dim ond 3 bag du. Rhoi ar y wefan. <i>Only 3 black bags.
